ENTRY CRITERIA 1. All children must take our Entrance Test to qualify

- entry to our courses. 2. The Entrance Test comprises an academic test, a
- reading test and may involve an interview in some cases. The test outcome will indicate if a student has sufficient knowledge in numeracy and literacy in order to be able to follow the pace of the course in a competitive group setting. Where there are gaps in knowledge then the student may be better prepared
- 3. Following the completion of the Entrance Test, if our course is deemed to be suitable for the learning needs of the child, then a formal offer will be sent to the Parent/Guardian via email.

- 4. Course fees must be paid in accordance with the Fees Metric for the relevant academic year.
- 5. Registration fee of £75 (non-refundable) and 1st
- term fee will be taken at least a week in advance to book the course. 6. As a fully managed all-inclusive course we don't
- charge on an hourly or per person basis. We only charge as a package and fee is to be paid on termly
- basis only. 7. Refunds will only be made during first 5 months of the start date of the course. Refunds are not made if

the child discontinues to attend the lessons. There is a

- 4 weeks' notice period applicable. 8. On completion of the Year 4 course, if the child
- continues to Year 5, only re-enrolment fee of £25 needs to be paid.
- 9. The course fees include books, end of term assessments and reports. Students in Year 5 also receive approximately 12 mock exams.
- 10. Students will also have a choice of getting one-toone tuition on a need basis. The fee will be charged on an hourly basis starting from £35 per hour for English
- and £45 per hour for Maths. 11. The enrolment of child will be suspended where any course fees remain outstanding for more than 2

- weeks. Please ensure you pay by the due date to avoid any disruption to your child's tuition. 12. We require that all Parent/Guardians supply us
- with written confirmation of their child's 11+ exam scores and a copy of the school offer letters received in
- March following the completion of the course. By agreeing to register the student on our course you
- consent to the disclosure of this information to us. 13. If your child misses a lesson, for whatever reason,
 - no refund can be issued. We will provide the material for missed lesson to practise at home. You will also have the option of booking a replacement one-to-one
