- Relationships Education, Relationships and Sex Education (RSE) and Health Education: Statutory guidance for governing bodies, proprietors, head teachers, principals, senior leadership teams, teachers

1. Aims

The aims of relationships and sex education (RSE) at our school are to:

- Provide a framework in which sensitive discussions can take place
- Prepare pupils for puberty, and give them an understanding of sexual development and the importance of health and hygiene
- Help pupils develop feelings of self-respect, confidence and empathy
- Create a positive culture around issues of sexuality and relationships
- Teach pupils the correct vocabulary to describe themselves and their bodies

2. Statutory requirements

As an independent school we must provide RSE to all pupils as per section 34 of the Children and Social work act 2017.

In teaching RSE, we must regard <u>guidance</u> issued by the secretary of state as outlined in section 403 of the <u>Education Act</u> 1996.

At Harrow Independent College (HIC), we teach RSE as set out in this policy.

3. Policy development

This policy has been developed in consultation with staff, pupils and parents.

4. Definition

RSE is about the emotional, social and cultural development of pupils, and involves learning about relationships, sexual health, sexuality, healthy lifestyles, diversity and personal identity.
RSE involves a combination of sharing information, and exploring issues and values. RSE is not about the promotion of sexual activity.

5.Curriculum

Our curriculum is set out as per Appendix 1 but we may need to adapt it as and when necessary. We have developed the curriculum in consultation with parents, pupils and staff, taking into account the age, needs and feelings of pupils. If pupils ask questions outside the scope of this policy, teachers will respond in an appropriate manner so they are fully informed and don't seek answers online.

6. Delivery of RSE

RSE is taught within the PSHE curriculum in dedicated lessons, assemblies, and tutor time. Biological aspects of RSE are taught within the Science curriculum.

RSE focuses on giving young people the information they need to help them develop healthy, nurturing relationships of all kinds including:

- Families
- Respectful relationships, including friendships
- Online and media
- Being safe
- intimate and sexual relationships, including sexual health

These areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBT parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers).

7. Roles and responsibilities

1. The Governing Body

The Governing Body will approve the RSE policy, and hold the headteacher to account for its implementation.

2. The Headteacher (Principal)

The headteacher is responsible for ensuring that RSE is taught consistently across the school, and for managing requests to withdraw pupils from non-statutory components of RSE (see section 8).

3. Staff

Staff are responsible for:

- Delivering RSE in a sensitive way
- Modelling positive attitudes to RSE
- Monitoring progress
- Responding to the needs of individual pupils
- Responding appropriately to pupils whose parents wish them to be withdrawn from the non-statutory components of RSE

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the headteacher.

8. Parents' right to withdraw

Parents have the right to withdraw their children from the non-statutory components of sex education within RSE up to and until 3 terms before the child turns 16. After this point, if the child wishes to receive sex education rather than being withdrawn, the school will arrange this.

Requests for withdrawal should be put in writing using the form found in Appendix 2 of this policy and addressed to the headteacher. A copy of withdrawal requests will be placed in the pupil's educational record. The headteacher will discuss the request with parents and take appropriate action. Alternative work will be given to pupils who are withdrawn from sex education.

9. Training

Staff are trained on the delivery of RSE as part of their induction and it is included in our continuing professional development calendar.

10. Monitoring arrangements

The delivery of RSE is monitored by SLT through learning walks, book scrutiny, lesson observations, and learner feedback. Pupils' development in RSE is monitored by class teachers as part of our internal assessment systems. This policy will be reviewed by Governors every 2 years. At every review, the Policy will be approved by the Curriculum Committee.

Years 12 & 13	 Manage mature friendships, including making friends in new places Manage personal safety in new relationships, including online activity or when meeting someone for the first time whom they met online Develop and maintain healthy, pleasurable relationships and explore different levels of emotional intimacy Evaluate different degrees of emotional intimacy in relationships, the role of pleasure, how they understand the difference between 'love' and 'lust' Use constructive dialogue to support relationships and negotiate difficulties Manage the ending of relationships safely and respectfully, including online Recognise the opportunities to build meaningful relationships in the workplace and the boundaries around professional relationships to develop a nuanced understanding of how to select appropriate contraception in different contexts and relationships 		

- Reduce the risk of contracting or passing on a sexually transmitted infection (STI)
- Take responsibility for their sexual health and know where, and how, to access local and national advice, diagnosis and treatment
- Understand the implications of unintended pregnancy and young parenthood; to recognise the advantages of delaying conception, whilst acknowledging the changes in fertility with age
- Negotiate, and if necessary be able to assert, the use of contraception with a sexual partner Effectively use different contraceptives, including how and where to access them
- Evaluate the most appropriate methods of contraception in different circumstances (including emergency contraception)
- Access the pathways available in the event of an unintended pregnancy and understand the importance of getting advice and support quickly
- Understand the moral and legal responsibilities that someone seeking consent has, and the importance of respecting and protecting people's right to give, not give, or withdraw their consent (in all contexts, including online)
- Understand the emotional, physical, social and legal consequences of failing to respect others' right not to give or to withdraw consent
- Recognise, and seek help in the case of, sexual abuse, exploitation, assault or rape, and the process for reporting to appropriate authorities
- Recognise and manage negative influence, manipulation and persuasion in a variety of contexts, including online.
- Recognise and manage different forms of abuse, sources of support and exit strategies for unhealthy relationships
- Recognise forced marriage and 'honour' based violence; to get help for themselves or others they believe to be at immediate or future risk
- Understand their rights in relation to harassment (including online) and stalking,
- how to respond and how to access support
- Strategies to recognise, de-escalate and exit aggressive social situations
- Evaluate the dangers and consequences of being involved in gangs, serious organised crime or carrying a weapon
- Ways to celebrate cultural diversity, promote inclusion and safely challenge prejudice and discrimination

*Phrases in bold refer to areas of statutory RSE, which parents can request their child to be removed from.
